**HOW PRC TAX
CREDIT WORKS:**

- 1 Donate \$100 or more to Coalition Life
- 2 Coalition Life will send you a tax credit application
- 3 Fill out the application and send it back to Coalition Life
- 4 Coalition Life will submit the application to the State on your behalf
- 5 The State will send you paperwork to keep for your taxes (45-90 business days)

Tax credits are NOT deductions. Deductions reduce your total income before taxes owed are assessed, while tax credits directly reduce the amount of tax you owe. This means tax credits have a much greater impact on your Missouri taxes and can be a huge benefit to you.
