## HOW PRC TAX CREDIT WORKS:

- 1** Donate \$100 or more to Coalition Life
- 2** Coalition Life will send you a tax credit application
- 3** Return the completed form to Coalition Life
- 4** Coalition Life will process and submit the application to the State on your behalf
- 5** The State will send you paperwork to keep for your taxes (45-90 business days)

## WHY DO YOU WANT A TAX CREDIT?

A tax credit is not the same as a deduction. Deductions reduce your taxable income while tax credits directly reduce the amount of tax you owe. In fact **70% of your eligible donation** to Coalition Life (up to \$71,500 per calendar year) may qualify for a tax credit for your business or individual Missouri tax return.
